The Regional Grants Navigator (RGN) position is a new position developed by the State of Colorado and administered by the local governmental agency (NECALG) to help support local communities receive ARPA, IJIA, and IRA funding. I provide support in grant research, guiding the grant application and writing process, and provide assistance through the life of the grant. Additionally, I am a resource among resources. In Region 1, we are well supported through many agencies including DOLA, USDA, and OEDIT. Working alongside these agencies and local community leaders helps create the network needed to ensure our communities are successful in receiving grants.

USDA Rural Development Energy Grants

Several different grants provide funding to complete energy audits, provide renewable energy development assistance, make energy efficiency improvements and install renewable energy systems. Programs help convert older heating sources to cleaner technologies, produce advanced biofuels, install solar panels, build biorefineries, and much more.

USDA Rural Energy for America Program (REAP)

Due: Multiple due dates: Dec 31, 2023; Mar 31, Jun 30, and Sep 30, 2024

The program provides guaranteed loan financing and grant funding to agricultural producers and rural small businesses for renewable energy systems or to make energy efficiency improvements. Agricultural producers may also apply for new energy efficient equipment and new system loans for agricultural production and processing.

Prop 123 - <https://coloradoaffordablehousingfinancingfund.com/about/>

A ballot measure authorizing the state to retain money from existing state tax revenue to support affordable housing investment. These funds are split 60/40 between the Office of Economic Development and International Trade (OEDIT) and the Department of Local Affairs (DOLA) through its Division of Housing (DOH), respectively. OEDIT manages the Affordable Housing Financing Fund in partnership with Colorado Housing and Finance Authority (CHFA), which serves as Contract Administrator. DOH manages the Affordable Housing Support Fund. Click the link above for more information.

EPA Water Infrastructure Finance & Innovation Act (WIFIA)

Due: Available on an ongoing basis

Federal loan initiative overseen by the Environmental Protection Agency (EPA). Its primary goal is to expedite investments in the country's water infrastructure by offering extended-term, low-cost, supplementary credit support for projects of regional and national significance. For this latest funding round, the EPA has identified specific priority areas, including: increasing investment in economically distressed communities; accelerating lead service line replacement; Addressing issues related to PFAS (Per- and Polyfluoroalkyl Substances) and emerging contaminants; mitigating the impacts of drought; and supporting water innovation and resilience.

Thriving Communities – helps with more than transportation.

Due: Nov 15, 2023

DOT is now accepting applications for its fiscal year (FY) 2023 Thriving Communities Program (TCP). TCP offers two separate response opportunities for potential applicants: a **Letter of Interest** and a **Notice of Funding Opportunity** (NOFO), which are described below. Under the NOFO, DOT is accepting applications for both the [Thriving Communities National Capacity Builder Program](#) and a new [Regional Pilot Program](#). Thriving Communities Program (TCP) will provide 2 years of deep-dive assistance and 3 years of facilitated peer learning support to selected communities to help them plan and develop a pipeline of comprehensive transportation, housing, and community revitalization activities.

DOE Carbon Capture Technology Program

DUE: Nov 16, 2023

Assists energy providers and other eligible entities in lowering energy costs for families and individuals in communities with extremely high per-household energy costs (275 percent of the national average or higher.)

Innovative Finance and Asset Concession Grant Program (IFACGP or the Program)

Due: Nov 17, 2023

Up to \$38.86 million will be awarded on a competitive basis to assist eligible public entities in facilitating and evaluating public-private partnerships and exploring opportunities for innovative financing and delivery for eligible transportation infrastructure projects, including highway, transit, passenger rail, certain freight facilities, certain port projects, rural infrastructure projects, airports, and transit-oriented development projects. Eligible applicants for this Program are public entities that own, control, or maintain assets that could be developed into enhanced assets. Eligible assets are those activities that would reasonably be deemed eligible to receive a Transportation Infrastructure Finance and Innovation Act (TIFIA) loan through the Bureau.

FAA – Funding Aviation’s Sustainable Transition vis Sustainable (FAST) Aviation Fuels

Due: Nov 27, 2023

Focused on sustainable aviation fuel (SAF), to be termed FAST-SAF, and elements focused on low-emission aviation technologies, to be termed FAST-Tech. The amount of available funding for the FAST Grant Program is \$244.53M and \$46.53M for FAST-SAF and FAST-Tech, respectively. The purpose of the FAST Grant Program is to make grants available to eligible entities for projects that support sustainable aviation fuels and low-emission aviation technologies.

USDOT Thriving Communities Program (TCP)

TCP provides technical assistance, planning, and capacity building support to teams of community partners that may lack the staffing or technical expertise to scope, fund, and develop infrastructure projects that advance broader community goals. TCP will provide 2 years of deep-dive assistance and 3 years of facilitated peer learning support to selected communities to help them plan and develop a pipeline of comprehensive transportation, housing, and community revitalization activities.

Implement Grant **Due: Dec 11, 2023**, Supplemental Grant **Due: Mar 4, 2024**

The Choice Neighborhoods program leverages significant public and private dollars to support locally driven strategies that address struggling neighborhoods with distressed public or HUD-assisted housing through a comprehensive approach to neighborhood transformation. Local leaders, residents, and stakeholders, such as public housing authorities, cities, schools, police, business owners, nonprofits, and private developers, come together to create and implement a plan that revitalizes distressed HUD housing and addresses the challenges in the surrounding neighborhood. The program helps communities transform neighborhoods by revitalizing severely distressed public and/or assisted housing and

catalyzing critical improvements in the neighborhood, including vacant property, housing, businesses, services and schools.
