CHFA Equity Programs, Opens 3-18-24 closes 4-18-24

The Equity program provides below-market-rate equity investments to eligible for-profit and nonprofit entities for the construction or preservation of low- and middle-income multifamily rental developments. A Tenant Equity Vehicle (TEV), funded through program earnings, will be required for developments receiving Equity financing. DOE 2024 Renew America's Schools Prize

DOE is now accepting submissions for the 2024 Renew America's Schools Prize, a \$180 million investment in K-12 public schools across the country. This three-phase opportunity will help districts build capacity, perform energy audits, and plan/implement energy improvement projects across a portfolio of school facilities.

Eligible Applicants: Schools, Nonprofit organizations that have the knowledge and capacity to partner and assist with energy improvements; For-profit organizations that have the knowledge and capacity to partner and assist with energy improvements; Community partners that have the knowledge and capacity to partner and assist with energy improvements.
