Good News!

Colorado U.S. Senators Michael Bennet and John Hickenlooper welcomed the National Telecommunications and Information Administration's (NTIA) waiver notice for letter of credit requirements that were included as part of the Bipartisan Infrastructure Law's Broadband Equity, Access, and Deployment (BEAD) program. The original letter of credit requirements would have made it difficult for small Colorado providers – including nonprofits, municipalities, and utilities – to apply for BEAD funding. In October, Bennet and Hickenlooper joined colleagues to urge NTIA to revise this requirement and allow for alternative methods of surety. Earlier, Bennet wrote to U.S. Department of Commerce Assistant Secretary and NTIA Administrator Alan Davidson to outline the unique obstacles the letter of credit requirement posed to Colorado providers. FUNDING AND TECHNICAL ASSISTANCE

Safe Routes Partnership will be accepting applications October 2 through **November 21** to participate in the 2024 Safe Routes to Parks Activating Communities program. Four communities will be selected to receive technical assistance and coaching to advance their goals of improving walking, biking, and rolling to local parks, greenways, and trails. Selected organizations will also receive \$10,000 to implement early actions to improve park access. Learn more in an information session on November 1.

Building Better Places, through Community Builders, brings together teams of local leaders to understand and address key challenges and opportunities facing their community, blending shared learning with facilitated action planning and helps community teams find common ground on workable strategies to move forward with addressing key needs and opportunities in their communities. Apply by **November 30**.

The Colorado Energy Office has \$2.5 million available to provide more opportunities to get rebates on <u>e-bike purchases</u>. Local governments can apply for this grant program to create their own rebate programs for low-income residents. Apply by **November 30**.

Directing place-based development, redevelopment, and housing in downtowns is a critical component to a robust and active economy, local government fiscal health, and sustainable development patterns. Main Street LIVE will fund downtown public infrastructure and facilities as Livability Investments for Vibrant Economies is an initiative of the Department of Local Affairs Energy/Mineral Impact Assistance Fund – work with your regional manager and apply by December 1 to take advantage of the reduced match requirement.

T-Mobile Hometown Grants provide up to \$50,000 to fund projects to build, rebuild, or refresh community spaces that help foster local connections in your community. Submissions close on **January 2, 2024**.

The Office of Economic Development & International Trade is providing grants, as well as training and consultation support, to businesses that are facing displacement pressures and that hold cultural, social, or historical significance in Colorado. The <u>Community Business Preservation Program</u> is accepting applications through **January 19, 2024**.

Downtown Colorado, Inc. invites all Colorado Communities to get involved with the <u>Colorado Challenge Accelerator Program</u>, which includes six months of training and guided project development and access to one-on-one support and regular peer meetings.
